**Rules and Policies for 2021 Summer Season at Bryant Midtown Citron Pool**

The following rules have been adopted by the Board of Directors for the benefit and protection of all pool members to assure the safe and sanitary operation of the pool and to provide a pleasant atmosphere for all members and guests. Adult members agree that they will be responsible for the behavior of any children and guests and will impress upon them that the observation of instructions of the Council Employee is mandatory and will supersede these rules and policies.

**A. GENERAL**

1. The Pool Manager will designate Council Employees (hereafter "CE") and either the Manager or the CE shall, at all times, have complete and absolute authority to enforce the rules for the safety, health and welfare of members and guests. Because it is impossible to predict all situations that may arise during the operation of the pool, **this is the single most important rule.**
2. Members and guests **must** register upon entering the pool whether a CE is present or not.
3. The Bryant Midtown Council shall not be responsible for loss or damage to member or guest personal property.
4. The cost of damages to council property by a member, member's family or member's guests shall be the responsibility of the member and the repair or replacement costs will be paid immediately upon presentation of a statement by the Council.
5. These rules may be revised or additional rules may be established at any time.
6. Suggestions and/or complaints concerning these rules should be submitted to the Pool Manager, Rachel Arrington who may be contacted at 501-529-8401. The Pool Manager has full and final authority to settle any problems.
7. No body contact except in the case of a parent giving instructions to minor children will be allowed.

## B. SAFETY

1. Swimming will be at the risk of members and guests. The Bryant Midtown Council is not to be held responsible for having a Lifeguard or CE on the premises at any time.
2. Instructions of the Council Employee will be immediately followed.
3. No running, pushing, roughhousing or other horseplay will be allowed within the fenced area of the pool.
4. No tubes, inflatable or floating rafts or other flotation devices will be allowed when the pool is crowded. The Pool Manager or CE shall have sole authority to decide if those devices are allowed.
5. **No glass containers will be allowed** within the fenced area of the pool and eating is only allowed at the tables provided. All canned drinks must be in a koozie. We allow alcohol as long as there is no extreme drinking occurring. **No eating or drinking is allowed in or around the sides of the pool.**
6. Only swimmers will be allowed in the deep water. For purposes of these rules, a "swimmer" is defined as one who is able to jump into deep water and swim one length of the pool to the satisfaction of the Pool Manager or CE. The Pool Manager or CE may request demonstration of swimming ability by asking anyone wishing to swim in deep water to demonstrate the ability described herein.
7. A responsible person who is aged 15 or over must accompany children under 15 years of age on the pool grounds.

## C. HEALTH AND SANITARY OPERATIONS

1. No one shall be admitted who has open sores, skin rashes or communicable infections or diseases in accordance the Arkansas state law. The Pool Manager or a CE shall have sole discretion to deny entry to the pool to anyone with apparent sores, rashes or infections.
2. No smoking, gum chewing or pets will be allowed within the fenced-in area of the pool. 3. No street shoes shall be worn on the pool apron.
4. No person who is not toilet trained will be allowed in the main pool because of possible harm to the pool filtration system. Only approved "swim diapers" are allowed in the wading pool.
5. Altered street clothes such as cut-off jeans are not permitted in the pool because of possible harm to the pool filtration system.
6. ***In order to avoid harm to the pool filtration system, suntan oil or baby oil is not allowed within the entire pool enclosure. Anyone***

***caught using these products will be required to leave.***

**D. GENERAL CONDUCT**

1. Members are expected to observe normal rules of good conduct and courtesy in order to make the pool a more pleasant place for all members and guests. All trash, toys and towels should be picked up from the pool area before leaving.

2. No abusive or profane language will be allowed.

3. The wading or baby pool is primarily intended for the enjoyment of children who are too small for the main pool. Behavior that is not consistent with this purpose will not be tolerated. Parents must watch their children in this pool.

4.. No one but the employees will be allowed to sit in the lifeguard stand.

**E. GUESTS**

1. Each guest must be accompanied by a member and will register on the page provided. There is a one-to-one ratio for guests to members unless approved by the pool manager. If someone is found in the pool who has been given the entrance code by a member, that member and his or her family will no longer be allowed to enter the pool and will forfeit the amount paid for the summer membership. Any person entering the area without a member present will be banned from the pool for the season.

2. Each guest over 1 year old will be charged a fee of \$5.00 per visit.

3. Each member family with minor children will be allowed one non-member babysitter who is 15 or over whose contact information has been provided on the Membership Application of the member family. That babysitter will only be allowed at the pool when in attendance with the minor children, in place of the adult member.

4. Guests will not be allowed on a holiday or a holiday week-end unless approved in advance by the Pool Manager. The Pool Manager will only consider approving guests if they will be staying in the home of a member for the holiday.

**F. OTHER**

1. At any time there is thunder and lightning, the pool and deck must be cleared for safety reasons. The pool will remain evacuated until no thunder is heard or lightning is seen for 20 minutes.

2. Whenever possible, walking or biking to the pool is encouraged as parking space is limited. Traffic must always be on watch for children and traffic signals will be observed and parking is only allowed on the right side of the streets around pool. No parking will be allowed within 25 feet of a street intersection to allow for emergency vehicle access.

3. Members may rent the pool for a party for a fee of \$100.00 per hour and may have a total of up to 20 guests. Holiday weekends are excluded. Parties will be set up at the deep end

against the wall. Paid members will still be able to enjoy the pool during a paid party period. All persons attending the party will swim at their own risks and the member will be responsible for the observance of all pool rules along with the cleaning up after the event. The Bryant Midtown Council will not be responsible for providing a CE or Life Guard for the party. All parties must end by 8:00 P.M.

4. Any person violating these rules or refusing to abide by the orders and rules established herein or at a future date by The Bryant Midtown Council may, at the discretion of the Pool Manager and/or the CE, be removed from the pool premises and have swim privileges suspended for a specific period of time. Severe violations may be referred to the Board of Directors for consideration and extended loss of swim privileges, which may include loss of those privileges for the summer and may be imposed only by the board.

5. No person will be allowed at the pool unless the membership fee has been paid and one adult for each family has executed the Membership Application stating that these rules have been read in full and will be obeyed by all members of the family.
